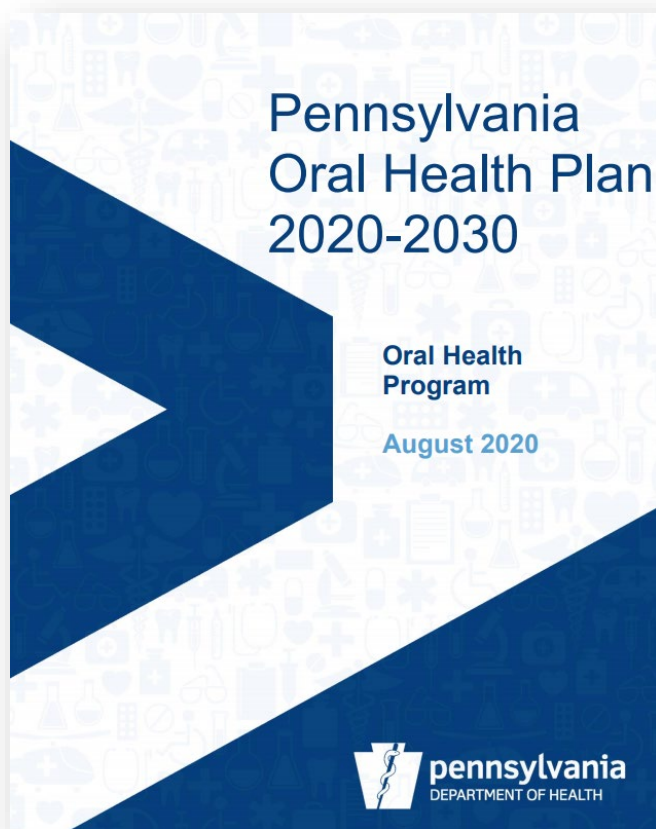

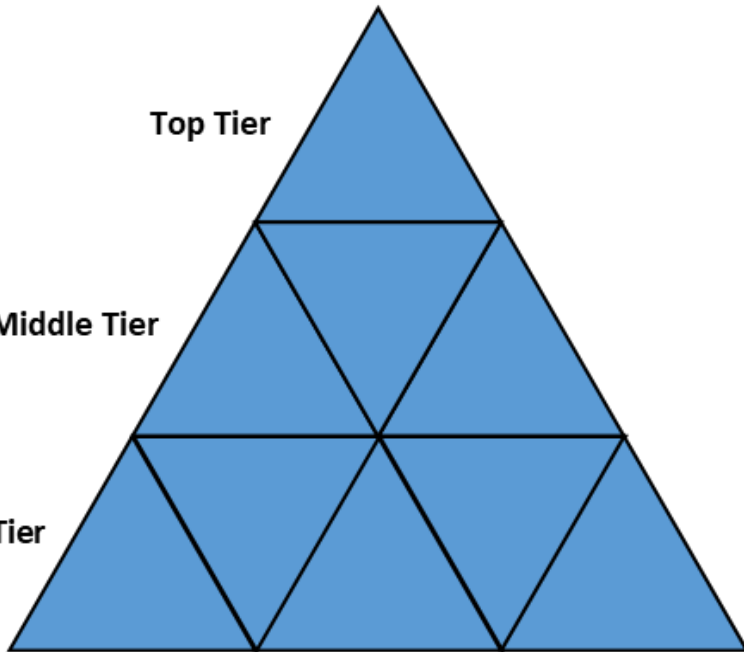

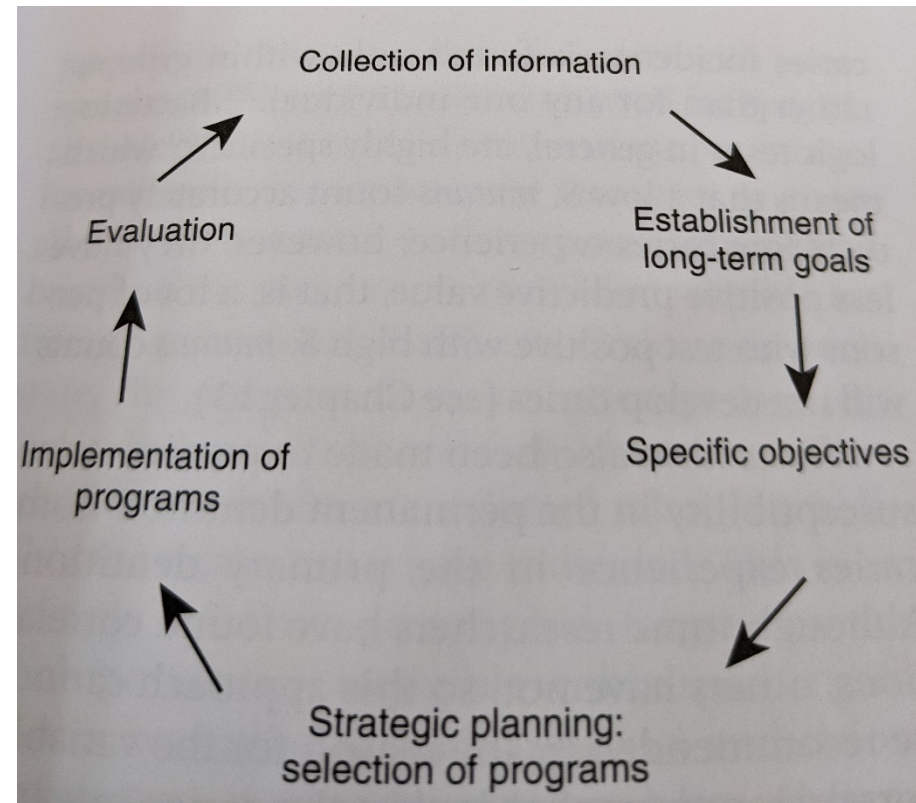

What is Dental Public Health?

- Assessment
 - Assess oral health status
 - Analyze determinants of oral health
 - Implement an oral health surveillance system
- Policy development
 - Develop plans and policies to support individual and community efforts to address oral health needs
- Assurance
 - Link people to needed population-based and personal oral health services

▶ Planning Cycle

- Analyze data collection
- Use data to identify and develop programs to meet needs
- Evaluate programs
- Modify programs, if needed
- Continue planning cycle



Surveillance, Infrastructure, and Capacity

- *Surveillance*
 - ▣ Includes ongoing systematic collection, analysis, and interpretation of health data essential to the planning, implementation, and evaluation of public health practice
- *Infrastructure*
 - ▣ Provides the necessary foundation for public health services
 - ▣ Addresses public health departments, health workforce development and training, data and information systems, planning and partnerships (Healthy People 2030)
- *Capacity*
 - ▣ Allows ability to perform activities and withstand threats

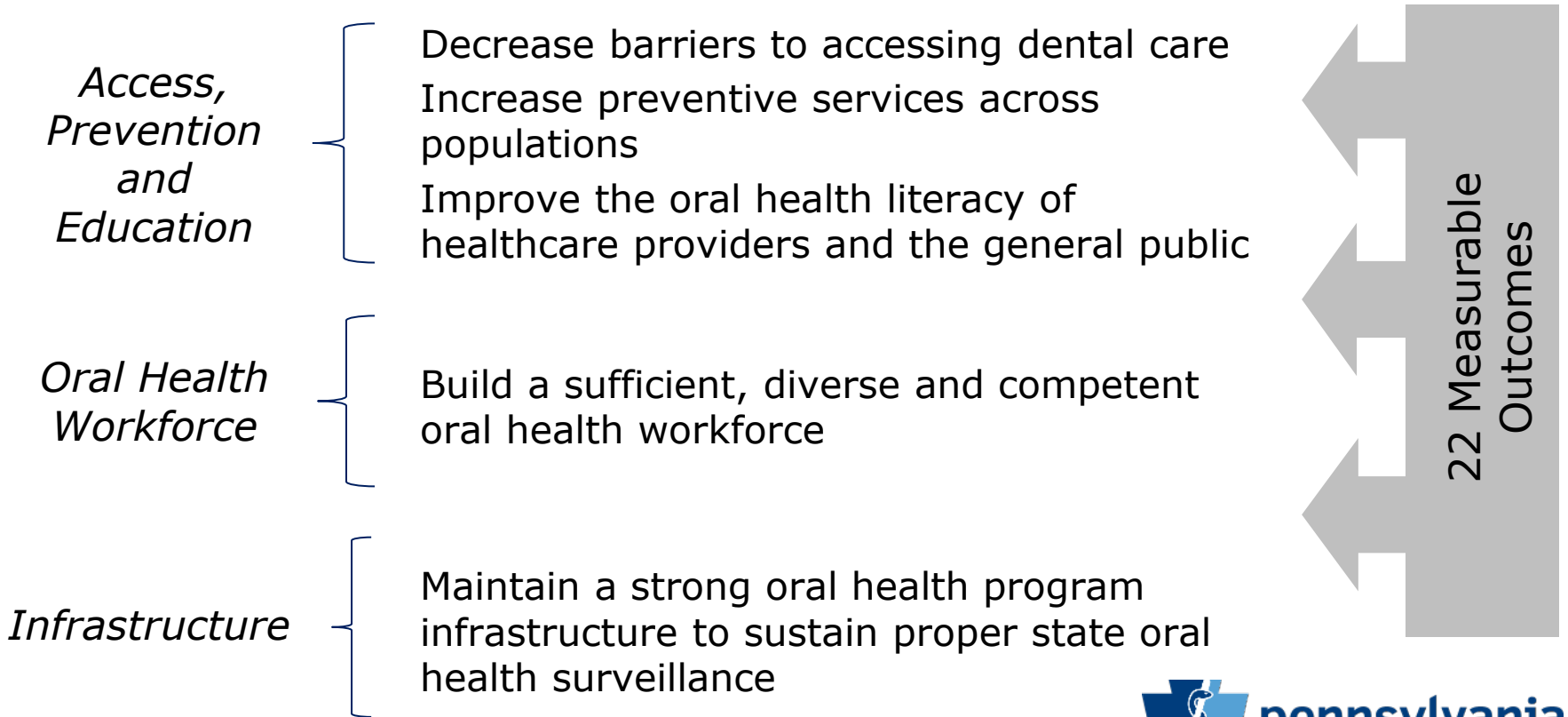

- SMART goals that align with the Pennsylvania Oral Health Surveillance System

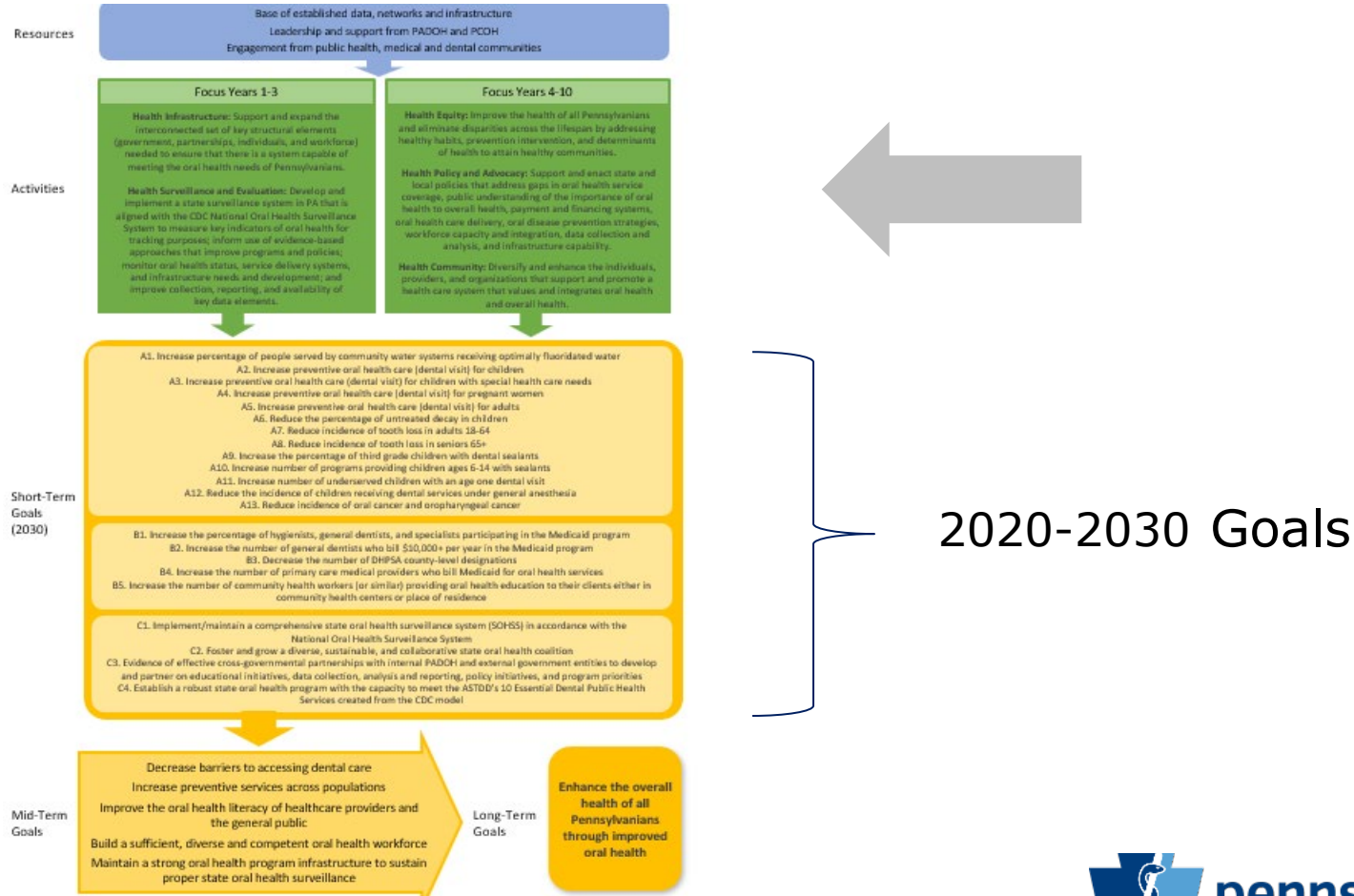

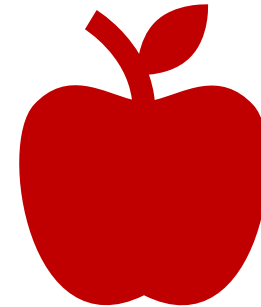
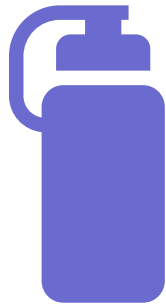
Logic Model
