## <u>A Message from Our Board Chair</u>

Well, that was a year. Things seemed to be getting better until they started getting worse. It is challenging and hard when you get your hopes up and then are disappointed. And yet, we persevered. We kept going, making new connections, starting new programs, investing our time and energy in activities for the future, showing by our actions that we believe that our investments will pay off.

At PCOH, we are dedicated to and enthusiastic about the future. In the past year, we rolled out the Basic Screening Survey in third grade classrooms, the first in Pennsylvania since 1998! The information we will obtain from this survey will give us a read on the current state of oral health in our children, something we haven't had, well, since 1998. This information can also serve as a baseline against which we can measure progress resulting from programs such as the School Sealant Program. Speaking of which, this year, we expanded the School Sealant Program from 61 to 78 interested programs, reaching 705 students. In addition to elementary students, we also connected over 400 high school students with information about career pathways in oral health, investing in building our oral health workforce for the future. We continued to grow the coalition, engaging with more than 25 new organizations across the state and nation. We also engaged in advocacy activities, supporting the extension of MA enrollment for pregnant women in PA (HB 2108) and promoting state resolution (HR68), Boosting Oral Health in Rural Communities, which passed through the legislature in March of 2021. We are envisioning a better future and working to make it happen.

Thank you for not giving up. Thank you for your continued efforts to make the future better for all Pennsylvanians. And thank you for supporting PCOH. It has been my honor to chair the Board of Directors these past two years.






### **Improving Oral Health for PA's Most Vulnerable Populations**

- Adult Dental Medicaid workgroup met monthly to protect current adult dental benefits and advocate for oral health legislation
- Awarded two mini grants, totaling \$8,000, to support work across the state that advances the priorities of the 2020-2030 PA Oral Health Plan\*
- Promoted state resolution (HR68), Boosting Oral Health in Rural Communities, which passed through the legislature in March of 2021
- Worked with all state managed care organizations to improve benefits for adult dental under Medicaid
- Served on multiple teams focused on increasing access to dental care for those with intellectual and developmental disabilities
- Provided oral health representation on the following groups and committees: Pennsylvania Cancer Coalition/HPV Workgroup, Pennie (PA Health Insurance Exchange) Outreach and Education Workgroup, PA Pregnancy Risk Assessment Monitoring System, and the Pritzker Children's Initiative







### **Supporting PA Oral Workforce Development**

- Expanded a dental career pipeline project utilizing *Teeth* by Mary Otto to spark interest in dental public health careers, which was completed with more than 200 participating dental and dental hygiene students\*
- Provided continued support for and participation in a wide range of regional oral health task forces across the state
- Reached 436 high school students in career pathway programs through presentations sponsored by regional Area Health Education Centers and local universities
- Trained nearly 300 dental staff and students using the Nicotine Dependence and Tobacco Cessation online course



### **Advocating for Community Water Fluoridation (CWF)**

- Coached and supported CWF advocates in preventing fluoridation rollbacks in 4 communities
- Worked with 3 communities interested in initiating water fluoridation
- Continued to collaborate with state officials and public health specialists to ensure public information about fluoridated water systems is as accurate as possible\*
- Continually updated a fluoridation status map of Pennsylvania
- Led and coordinated communications for the statewide CWF Task Force
- Attended four statewide water conferences and educated more than 900 individuals about community water fluoridation (top photos)
- Assisted the PA Department of Health in presenting water fluoridation awards on behalf of the American Dental Association, the Association of State and Territorial Dental Directors, and the Centers for Disease Control and Prevention (bottom photo)



### Advancing and Advocating for Oral Health Policy and Infrastructure Across All Systems

- Implemented third year of statewide charitable work tracking to collect data on free dental care being provided across Pennsylvania, collecting data on more than \$5.5 million in free services provided during 2020
- Supported the extension of Medicaid enrollment for pregnant women in PA (HB 2108)
- Provided oral health representation on the following committees: PA State Health Improvement Plan (SHIP), PA State Health Assessment (SHA), and the Coalition for the Common Health
- Promoted the federal addition of dental and vision to Medicare and adult coverage in Medicaid
- Met with three PA legislators and staff to discuss oral health issues in PA
- Partnered with the American Dental Association's Health Policy Institute to publish a dentist workforce study with policy recommendations for Pennsylvania

- Participated on boards of the PA Rural Health Association and the American Network of Oral Health Coalitions
- Continued support and leadership for the PA Family Oral Health Collective
- Engaged with more than 25 new organizations across the state and nation
- Established a "Request Materials" page on the PCOH website for stakeholders to download and request more than 2,200 pages of free oral health materials
- With the help of the PA Chapter, American Academy of Pediatrics and the PA Office of Rural Health, created a resource for parents emphasizing the type and amount of beverages that should be consumed by children at certain ages (*top right*)
- Created a resource for middle school and high school students raising awareness of the amount of sugar in popular beverages and empowering them to choose water (*right*)
- Celebrated 5 years of incorporation as a 501(c) 3 nonprofit organization in August
- Officially joined the board of the Northcentral Pennsylvania Area Health Education Center

Nearly 100 individuals were in attendance for this two-day event, filled with educational presentations, small group discussion, networking, and more. This year's agenda featured a lineup of two keynote addresses, a state of the state report, and twelve 15-minute presentations followed by small group discussions.

## **Grants Awarded**

The PA Department of Health Oral Health Program received funding from CDC and HRSA grants for 2018-2023 totaling \$3.45 million. PCOH is a key partner in these grants and works on numerous projects as a result of this partnership.

### Centers for Disease Control and Prevention (CDC) Improving Oral Health in Pennsylvania (IOH-PA)\* 2018-2023

- Major Partner: PA Department of Health Oral Health Program

- Assisted school sealant programs (SSPs) in providing more than 2,500 sealants to students in 31 schools across the state
- Awarded \$65,703 in grants to update fluoridation equipment in 5 community water systems
- Guaranteed continued fluoridation for more than 100,000 Pennsylvanians served by community water systems
- Administered a third-grade Basic Screening Survey to measure dental disease in school-age children across 80 schools in Pennsylvania along with investigating options to improve dental services and data collection through school health

# **Spotlight: YMCA Health Equity Tour**

In 2021, the Harrisburg Area YMCA and Pennie<sup>™</sup> kicked off the "YMCA Health Equity Tour." The Health Equity Tour is a series of in-person events throughout the 67 counties of PA focusing on access to health. During the tour, YMCA staff has distributed educational materials about COVID-19, oral health and water fluoridation, combatting senior social isolation, and the harmful effects of tobacco use and vaping. PCOH and the PA Chapter of the American Academy of Pediatrics (PAAAP) have provided thousands of oral health materials for distribution. Starting in May 2021 and through December, the tour has made 54 stops at locations across the state and provided materials to more than 5,000 individuals. There are 18 more stops currently scheduled for 2022.

## Here's what we're planning for 2022...

- Hold two virtual and four in-person stakeholder meetings, with a focus on engaging new stakeholders as well as continuing existing relationships
- Collect data for the fourth year of our charitable work tracking for free dental services
- Complete administration of a third-grade Basic Screening Survey to measure dental disease in school-age children in Pennsylvania along with investigating options to improve dental services and data collection through school health
- Advocate at the federal level for dental benefits to be added to Medicare and add support for dedicated oral health funding for every state
- Improve the percentage of Pennsylvanians who have access to optimally fluoridated drinking water by investigating new partnerships that promote drinking tap water and healthier beverage choices by all residents
- Offer dental continuing education credits in tobacco/nicotine cessation, HPV prevention, serving people with disabilities, community water fluoridation, and more
- Work with state and regional Area Health Education Centers on pathway projects to encourage students to pursue dental careers
- Expand our nicotine/tobacco cessation program to reach more dental providers and staff in locations such as schools and prisons
- Promote HPV prevention through vaccines to reduce oral cancer incidence
- Continue to implement the goals and action plans of the Pennsylvania Oral Health Plan 2020-2030
- Give health providers the support they need to educate and improve health for families in PA through our online materials page
