Improving Oral Health for PA's Most Vulnerable Populations

- Adult dental Medicaid workgroup met monthly to protect current adult dental benefits and advocate for legislation to increase coverage
- Awarded two mini grants, totaling \$8,000, to support work across the state that advances the priorities of the 2020-2030 PA Oral Health Plan*
- Disseminated findings from the Legislative Budget and Finance Committee's <u>"A Study Pursuant to House Resolution 68: Rural Dental Health"</u>
- >>> Worked with each of the state's managed care organizations to improve benefits for adult dental under Medicaid
- Served on diverse teams to enhance dental care access for individuals with intellectual and developmental disabilities, including advocacy for the <u>EMUP initiative</u> which would increase access to funding in this space
- >>> Provided oral health representation on many groups and committees, including the Coalition for the CommonHealth, PA Cancer Coalition/HPV Workgroup, PA Pregnancy Risk Assessment Monitoring System, Pritzker/P3N Children's Initiative, State Health Assessment, and State Health Improvement Plan
- >>> Hosted an informative training in Perry County to educate local advocates on the oral health status of the region
- Presented at the Pennsylvania Department of Health Special Health Care Needs Symposium to raise awareness on the oral health needs and access issues for individuals with intellectual and developmental disabilities*
- >>> Managed the School Sealant Program for the Oral Health Program, resulting in 1,218 children receiving dental sealants in 91 schools*

Supporting PA Oral Workforce Development

- >>> Initiated the first two semesters of a four-year dental career pipeline project utilizing *Dying from Dirty Teeth* by Angie Stone to educate students on the disparaging condition of oral health care for older adults and spark interest in dental public health careers, which was completed by 454 dental and dental hygiene students at 11 schools*
- >>> Reached over 450 high school students in career pathway programs through presentations and events sponsored by regional Area Health Education Centers and local schools
- >>> Trained nearly 400 dental staff, students, and providers using the <u>Nicotine Dependence and Tobacco Cessation online course</u> on the PCOH website
- >>> Provided continued support and participation for a wide range of county and regional oral health task forces across the state, including the Perry County Health Coalition and SUN Smiles
- >>> Presented and exhibited at the second annual community health worker conference to promote oral health education and share resources*
- Exhibited at the University of Pennsylvania School of Dental Medicine Career Fair to educate graduating dental students on the career opportunities available in public health
- Launched a <u>community health worker continuing education course</u> on the website that reached 83 community health workers in the state in 2023*
- Staff and volunteers participated in several career days at high schools and community colleges across the state to educate students on dental career opportunities
- Exhibited at the Northeast Pennsylvania Area Health Education Center's Healthcare Career Exploration Event that was attended by over 350 students from Northeast PA interested in healthcare careers
- Sponsored the Dental Assisting award at the SkillsUSA PA Leadership and Skills conference and provided dental career pathway materials for over 1,700 high school students
- Attended the PA School Counselors Association Annual Conference to disseminate dental career resources to school counselors across the state

Advocating for Community Water Fluoridation (CWF)

- Organized community water fluoridation advocacy efforts and addressed a fluoridation rollback in an Allegheny County community
- >>> Continued to collaborate with state officials and public health specialists to ensure public information about fluoridated water systems is as accurate as possible*
- Continually updated the PCOH <u>fluoridation status map</u> of Pennsylvania in partnership with the Pittsburgh Water Collaboratory*
- >>> Updated 1,898 community water systems in the CDC My Water's Fluoride public database for the first time in over a decade*
- >>> Led and coordinated communications for the statewide CWF Task Force*
- >>> Launched the Water Operator Thank You Campaign to organize public outreach efforts and show gratitude to water operators across the state providing communities with safe drinking water; 78 letters were sent in 2023*
- Attended and exhibited at 3 statewide water conferences and educated water system employees and decision-makers about community water fluoridation*
- Assisted the PA Department of Health in presenting fluoridation awards on behalf of the American Dental Association, the Association of State and Territorial Dental Directors, and the Centers for Disease Control and Prevention*
- Participated in a market research project with the American Fluoridation Society that surveyed 1,000 Pennsylvanians on their attitudes and knowledge of community water fluoridation in the state

Thank You, Water Operators! Tap Water Appreciation

Then was the last time you thanked the water operators in your community for delivering safe ator to your home? Tap water is something that many take for granted; we turn on our faucets nd the water flows. We don't often think of who was involved in making that happen. Water is sential for life and getting enough water every day is crucial for your health.

Tap water can be made even better with the adjustment of fluoride. Water fluoridation is simply the adjustment of the natural fluoride in water to the recommended level that prevents tooth decay. Communities with fluoridated water have 25% fewer cavities than communities without water fluoridation, even when families use other fluoride products like toothparte.

PCOH is encouraging Pennsylvanians to thank your water systems for delivering safe drinking water to homes, schools, child care centers, restaurants, and businesses.





Step 1:

Use the PCOH map to determine if your address is receiving fluoridated water and which water system supplies your home.

Are you served by a private well? No problem! You can still thank your nearby sys for providing safe, clean tap water to your workplace, child care center, school, restaurants, or other places you and/or your family members frequent.



Advancing and Advocating for Oral Health Policy and Infrastructure Across All Systems

- Whosted an Oral Health Advocacy Day in April at the Capitol that included a breakfast with legislators and staff, a press conference featuring the Majority Chair of the House Health Committee, and scheduled meetings with 25 legislators/legislative staff (see photos)
- Supported and advocated for four pieces of legislation including HB 1417, SB 955, HB 1585, and HB 1478; these bills include restoring dental coverage for adult medical assistance members, expansion of dental care through technology, and permitting school dental screenings by public health dental hygienists
- >>> Implemented the fifth year of statewide charitable work tracking to collect data on free dental care being provided across Pennsylvania and published a <u>report</u> including the past five years of data findings
- >>> PCOH staff advocated for increased dental access for veterans through an in-person Hill Day in Washington, D.C.
- >>> Continued to advocate for school districts in Pennsylvania to increase the number of Dental Hygiene Services Programs and for those districts to bill Medicaid directly for dental care
- Participate in dozens of conversations with leadership at the PA Department of Health and the PA Department of Human Services to improve dental care access and expand workforce
- >>> Elevated the importance of oral health in three interviews aired by WPMT Fox43 in conjunction with the April Advocacy Day at the Capitol; press conference was also featured on PA Cable Network (PCN) statewide









Other Successes

- Continued to support the PA Department of Health in facilitating the <u>Pennsylvania Oral Health</u> <u>Plan 2020-2030</u> and the Oral Health Plan Advisory Group
- Continued support and leadership for the PA Family Oral Health Collective workgroup
- Staff volunteered at several Remote Area Medical (RAM) clinics across the state as well as the Mission of Mercy Pittsburgh clinic
- Hosted two webinar updates in <u>June</u> and <u>December</u> for stakeholders and individuals interested in learning more about PCOH
- Staff attended and presented at the National Oral Health Conference in Orlando, Florida in April
- >>> Developed a "Finding Dental Care" resource in English and Spanish to be shared with community partners to identify social services, clinics, and other programs in the community where an individual might seek dental care
- >>> Hosted a statewide strategy session to address workforce challenges in collaboration with 42 key partners. This meeting yielded insights on training, retention, and recruitment strategies, along with action plans to continue these efforts.

Finding Dental Care in Pennsylvania

Federally Qualified Health Centers

Federally qualified health centers (FQHCs) are primary care facilities in rural and urban areas. There are more than 120 FQHC sites in PA that provide dental care, All insurances are accepted. Free and Charitable Clinics

- >>> Translated school sealant parent resources into Swahili and Haitian-Creole to better serve community needs
- Aided the Department of Health is compiling and disseminating a summary report of the <u>2021-2022 Third</u> <u>Grade Basic Screening Survey</u>
- >>> Received nearly 1,500 views in 2023 on the PCOH website fluoridation resource page



>>> Advocated for tracking and analysis of dental licensure data by the PA Department of Health Oral Health Program

- Continued our dental workforce pipeline program to reach high school students in underserved areas to encourage the consideration of dental careers
- Aided the PA Department of Health in sharing the 2021 Pennsylvania's Dentist and Dental Hygienist Workforce Survey Report that highlighted licensure survey trends



- >>> Launched an <u>oral health workforce dashboard</u> that provides interactive visuals for data presented in workforce reports, including the number and locations of dental professionals and the number of providers registered with Medicaid per county
- >>> Administered a survey of certified community health workers in PA to gauge oral health information being provided and gaps in oral health education
- >>> Published "Access to Oral Health Workforce Report Part II" detailing the results of a secret shopper survey and provider survey revealing underutilization of providers, rural challenges, limited capacity of clinics and offices, poor work-life balance, and an alarming disparity in the number of providers accepting patients with intellectual and developmental disabilities

2023 PA Oral Health Summit: Paving the Road to Equity

The 2023 Pennsylvania Oral Health Summit gathered oral health stakeholders from across Pennsylvania in-person for education, discussion, and networking. PCOH created an open space for open discussion and idea-sharing. The three-day event consisted of a poverty simulation, greetings from the Pennsylvania Department of Health and Pennsylvania Department of Human Services, a keynote address, three panels, 15 roundtable presentations, and seven short presentations from PA stakeholders. Each presentation was followed by small group discussion guided by prompted questions.













Quick Summit Takeaways

- >>> The event was at capacity with nearly 140 attendees, staff, sponsors, and presenters.
- >>> Attendees hailed from seven different states and 31 of Pennsylvania's 67 counties.
- >>> There were 77 first-time attendees at the event.
- >>> Three panel presentations were included and featured representatives from safety net clinics, rural and urban settings, as well as dental schools and other workforce advocates.
- >>> Attendees participated in roundtable sessions offered by 15+ oral health stakeholders from across PA.
- >>> PCOH presented the 2023 Innovative Oral Health Champion Individual Award to Kelly Braun of the Pennsylvania Office of Rural Health and the 2023 Innovative Oral Health Champion Organization Award to St. Luke's Miners Campus & Hometown Center Team.







- Offer dental continuing education credits in tobacco/nicotine cessation, HPV prevention, serving people with disabilities, community water fluoridation, and more
- >>> Continue to implement the goals and action plans of the Pennsylvania Oral Health Plan 2020-2030
- Award additional community water fluoridation grants to water systems to initiate or update their fluoridation practices
- >>> Finalize approval for the CDC Fluoridation Learning Online course for PA-specific credits for water operators
- >>> Add additional school sealant programs (SSPs)
- >>> Continue to offer free resources to oral health advocates and providers on the PCOH website, "Request Materials" page
- >>> Promote the development of dental assisting careers across the commonwealth by reviewing and revising current pathways
- Host a community water fluoridation celebration and continuing education event with the University of Pennsylvania School of Dental Medicine in honor of 70 years of community water fluoridation in Philadelphia
- >>> Host an informational webinar to educate stakeholders on dental license portability including dental licensure compact models
- >>> Collaborate with the Pennsylvania Department of Health to prepare a new statewide oral health surveillance plan
- >>> Move HB1417 and HB 1585 in the Senate after both bills passed in the House with bipartisan support
